



Cong protests FRDI Bill

Kolkata, December 26

The Congress on Tuesday took out a rally outside the RBI office here to protest against the proposed Financial Resolution and Deposit Insurance (FRDI) Bill, 2017.

"People will lose their lifelong deposits if this bill is passed. We will oppose the FRDI Bill tooth and nail. We will not stop until and unless it is withdrawn," Congress

chief whip in the Assembly Manoj Chakraborty, said.

The FRDI Bill proposes a framework for overseeing financial institutions such as banks, insurance companies, non-banking financial services companies and stock exchanges, in case of insolvency.

Assocham has said that the "bail-in" clause in the draft FRDI Bill, 2017 can potentially harm deposits in savings accounts.


